I. Eligibility Criteria

A. For Individuals

- a. Nationality: Should Be An Indian National.
- b. Educational Qualification: Passed Minimum 10th Standard (Examination conducted by a board/School)
- c. Age: As On the Date of Application (In Completed Years) Not Less Than 21 Years and not more than 60 years.
- d. Financial strength: Should have sufficient financial strength
- e. Experience: applicant with the experience in the following field / activities shall be given priority.
 - i. Forecourt management of retail outlet of petroleum products
 - ii. Working experience in oil and gas sector

The documentary proof fulfilling the above criteria shall be submitted by the applicant along with the application form.

B. For Others

- a. Partnerships: In case of partnerships, All partners to individually fulfil the eligibility criteria as specified above (for individual)
- b. Registered Co-op / Consumer Societies: In case of registered Co-operatives/ consumer societies, there should be at least one person fulfilling above eligibility criteria (for individual).
- c. In case of a firms / companies / organized bodies, there should be at least two persons fulfilling above eligibility criteria.

J. Broad Terms and conditions for land

- a. Applicant/Family member should be the Owner of the offered plot or should be holding long term Registered Lease deed.
- b. The land should be available with the applicant as on the date of application and should have minimum lease of 12 years from the date or after the date of advertisement but not later than the date of application.
- c. If the offered land is on Long term lease, then the Lease agreement should have a provision to sub-lease the land wherever the locations are advertised

In case it is observed that the lease agreement for the land offered by the selected applicant does not have a provision to sub-lease the land, in such cases the selected applicant would be provided 21 days' time from the date of intimation through SMS/e-mail to make suitable amendment / addendum to the lease agreement and submit the same.

- d. Interested parties should offer open plots with clear & undisputed title only.
- e. Frontage of plot of land should be abutting the National highway/State highway.
- f. The Plot size should be minimum 1200 SQMT on State highway and 1500 SQMT on National highway (excluding building control limit) with minimum clear frontage of 35 Meter.
- g. The plot size indicated above shall be measured after leaving applicable ROW as per norms of NHAI/PWD/CPWD/State Highway Deptt./Local Authorities etc.
- h. In case of land situated on national highway, the applicant will ensure that the land Offered meets the NHAI guidelines issued by Govt. of India, Ministry of Road, Transport & Highways from time to time. The offered land should also meet norms of statutory bodies like forest, explosive etc. and the land should be convertible for commercial and CNG Station use.
- i. The applicant shall arrange all statutory clearances such as Title Clearance, Non-Agriculture conversion, District Magistrate NOC / Police Commissioner NOC and no Objection certificate from co-owners, if any.
- j. Bidders offering agricultural land shall convert the same to non-agricultural purposed more particularly for the use of CNG stations or other allied purposes at their own expense and cost within a period of maximum 60 days. Failing which M/s Sabarmati Gas Limited shall withdraw Lol and take appropriate actions.
- k. If the entire land does not belong to the bidder then the group of persons who have plots contiguous to each other meeting our requirement can quote through one of them holding Power of Attorney for the others.
- l. The Proposed Franchisee agrees to execute necessary land lease deed in favour of Sabarmati Gas Limited at least for a period of 10 years at least 15 days prior to execution of Franchisee agreement. SGL shall pay amount of Rs. 1/- (Rs. One only) per annum towards land lease rental and remain fixed for land lease tenure.
- m. The land must be suitable for development for CNG station and other commercial activities and impact charges, if any, need to be paid to the local development authorities right now or in future also, the same shall be paid by the land owner/applicant & the same shall never be recoverable from Sabarmati Gas Limited.
- n. Brokers/Property dealers need not apply.

- o. The land owned by the family member(s) will also be considered as belonging to the applicant subject to producing the consent letter in the form of affidavit from the concerned family member(s) as per Annexure I

- p. In case the applicant or family member(s) own the land jointly with third person, the consent letter in the form of an Affidavit (Annexure I) or Power of Attorney (Registered) clearly authorizing the applicant for such use of land from third person is also required.

- q. Specific Requirement of applicants applying under Partnership:

In case of partnership, each partner should individually meet the eligibility criteria for applying as an individual. However, the land owned by partner(s) will be treated as owned by the proposed firm as a whole for the purpose of eligibility.

Each partner should submit separate application form along with separate non-refundable application fee. However, the applications should be clubbed together. They also would be required to submit a copy of the partnership deed.

- r. Eligibility Criteria For Non-Individual Applicants (Entity)

Non-individual entity applicant means Government Bodies/Agencies, Societies registered under Societies Registration Act 1860 / Societies registered under Co- operative Societies Act, 1912 or Co- operative Societies Act as enacted by concerned States, Charitable Trusts registered with Charity Commissioner of respective State Government, Companies formed under the Companies Act, 1956 / 2013, including Pvt. Ltd. companies.

Residential status: The entity should be registered in India.

Age: The date of Registration / Incorporation of the firm / entity should be a least 3 years prior to the date of application.

Land : With regard to land, all conditions covered for individuals would apply excepting clauses given for land owned by family member(s). In other words, the offered land should either be owned or on long lease in the name of entity and not in individual name.

Finance : Registered Societies / Companies should have made a net profit for previous 3 consecutive financial years duly certified by a Chartered Accountant.

- s. Registered Societies / Charitable Trusts / Companies will have to furnish appropriate resolution to show that person making the application on its behalf is empowered to make the same. Authorized signatory on behalf of the entity will also have to furnish an undertaking that it will observe the relevant guidelines

With regard to submission of documents by selected entities, time limits as given under individual applicants would apply.

K. Broad scope of work

Scope of M/s Sabarmati Gas Limited:

- a. Sabarmati Gas Limited will open either mother / online / booster / daughter station depending upon the requirement.
- b. The initial layout for obtaining PESO approval shall be prepared by Sabarmati Gas.
- c. All the CNG equipment's like compressor, dispenser, and cascade will be installed and commissioned by Sabarmati Gas Limited.
- d. All periodic and break down maintenance of CNG equipment will be in the scope of M/s Sabarmati Gas Limited.
- e. The cost of power towards running of compressor and dispenser will be reimbursed by M/s Sabarmati Gas Limited (a separate meter to be provided).
- f. Sabarmati Gas will train the technicians / manpower hired / deployed by the applicant for dispensing
- g. Sabarmati Gas will pay Franchisee Commission towards the provision of land, utilities, dispensing arrangements and other services rendered at CNG station.

The above-mentioned scope is subject to change at the discretion of M/s Sabarmati Gas Limited.

M. Applicant's Scope:

- a. All necessary permissions required from all statutory authorities (like Chief Controller of Explosives (CCOE) – Nagpur, local office, local Municipal office, District Magistrate NOC (DM NOC) / Police Commissioner NOC (PC NOC), NHAJ etc.) for setting up of CNG station.
- b. Change in Land Use: Applicant shall get the change of land use from Agriculture to Non Agriculture (NA Commercial) for CNG station before the project activities are commenced at the land.
- c. The entire plot has to be developed exclusively for setting up of CNG station only and no other activity shall be allowed.
- d. All civil works such as foundations, canopies, electrical rooms, trenches, driveway, boundary wall, Sales room, other facilities etc are in the scope of the applicant. The technical details & design will be provided by the Sabarmati Gas.
- e. Power connection under the Industrial category up to the site has to be arranged by the applicant. All necessary permissions including deposits, cable charges, connection charges etc as levied by the Power licensee for obtaining power supply shall be in the scope of the applicant. If the transformer and other associated electrical equipment are required for supplying power, then the same shall be in the scope of the applicant.
- f. Power cost towards illumination of the station is in the scope of applicant (a separate meter will have to be provided by the applicant).
- g. All manpower required for smooth operation of equipment's installed at the station and dispensing of CNG to vehicles including security of station.
- h. Day to day operations like dispensing and maintaining the CNG outlet (as per standards of Sabarmati Gas) shall be in the scope of the applicant.
- i. An interest free Security deposit of amount Rs.10,00,000/- (Rs. Ten Lakh) is required to be submitted at least 7 days prior to Commissioning / Commercialization of CNG station. Post commissioning of CNG station, security equivalent to 3 days CNG sales is required to be maintained. Based on the actual sales, the security deposit may vary. Sabarmati Gas reserves the right to enhance security deposit without assigning any reasons.
- j. Telephone facilities, cabin with table, chair etc. for compressor operator has to be provided by the applicant at his own cost.
